

Current challenges:

In today's rapidly evolving business landscape, organisations face the ongoing challenge of boosting productivity to remain competitive. Some of data points are as follows:

- Gartner has predicted that productivity will be top 5 key priority for CEOs by 2025.
- ▶ The Productivity Commission's report highlights that Australia experienced a significant 3.5 percent drop in average output per hour worked in 2022, marking the fastest decline on record.
- ▶ In Australia, economic output per person – a general measure of prosperity – is about 7 times higher than at Federation (122 years ago).¹ This transformation is ultimately a function of human ingenuity: of being more productive – working smarter not harder.

Relationship between productivity and digital investments:

- The productivity growth is at the lowest point in 2023 and unit labour cost is at the highest point in the respective time period.
- ▶ The investment in AI and automation has grown by 7 times in last 8 years.


Why lower productivity is becoming a key challenge in Australia:


- Lowest unemployment rate
- Small population base which limits pool of potential workers
- Higher inflation-high labour cost
- Low adoption of technology.

Main driver for the investment in AI and automation opportunity


The main driver for organisations to leverage AI and Automation is to enhance productivity
